

CONTRACT

For due and valuable consideration, hereby acknowledged and received, the undersigned Iowa Cedar Creek Whitetail, LLC hereafter (ICCW) and _____ hereafter (Participant), hereby agree as follows:

1. **General.** ICCW shall provide the location, stands, one meal a day and opportunity to locate game to Participant.

2. **Accommodations and Transportation.** Participant shall provide his own accommodations, including room, board and transportation to and from the hunting site. All Participants shall have a current Iowa hunting license and hunting tag appropriate to their hunt. Participants shall provide the following information:

In addition, a drivers license photo ID shall be submitted for copying together with a copy of your Iowa hunters License and Tags.

3. **Stands.** ICCW provide pre hung stands and shooting houses from decades of hunting experience on the properties, placed with utmost care in monitoring the patterns, habits, tracts, terrain, weather, feeding of game, and all variables necessary to accommodate your best hunt. Any manipulation of stands or houses is prohibited unless previously agreed by your guide.

4. **Type of Hunt.**

All guided hunts include a tour of the hunt location and scouting report with views of all prepared stands and shooting houses, except the unguided Spring Turkey Hunt when a property tour is provided.

5. **Payment.** All payments are due prior to hunt with Participant providing a \$475. nonrefundable deposit upon making reservation for deer hunt and a \$100. nonrefundable deposit for turkey hunt. *Exception:* In the event Participant is unable to secure an Iowa DNR Tag, the deposit shall be carried over to the next year. In the event Participant is unsuccessful in obtaining a tag for two consecutive years, the deposit shall be refunded.

6. **Film Rights.** ICCW, its employees, agents and officers are hereby granted full rights to, and Participant hereby releases and waives all right, title and interest in and to videos, photos or reproductive film processes taken during or associated with the hunt, with all rights reserved to ICCW for its use, particularly in marketing hunting operations.

7. **Harvesting Bucks.** ICCW strives to produce and provide quality mature bucks and requires Participant to abide by our practices of harvesting a minimum 140" or Pope and Young gross scored bucks. In the event a 139" or less scored buck is harvested, Participant shall incur and pay an additional \$475 charge. In the event an animal, although shot is not recovered, ICCW shall allow Participant to continue the hunt for an additional \$475 with the option to elect the non-recovered animal as their kill.

8. **Inclusion.** Attached to and specifically made a part of this Contract as if fully set forth herein, are Release, Hold Harmless and Indemnification provisions. Those terms are fully accepted and agreed by Participant. Participant agrees that the terms herein are fully applicable and binding on the Participant's heirs, successors and assigns.
